





#### OCTOBER 2020 NOMINATING COMMITTEE:

I have appointed the 2021 Officer Nominating Committee ahead of the October meeting this year. Frank Wildeman, Mark Meyer and Mark Weil have agreed to take up this task. For clarification, all Club Offices are up for nomination at the November meeting as outlined in the Club Bylaws. I have been asked if there was a written description for each of the Club Officer roles. I looked through the Club Bylaws and found that the duties of the Office of President is fairly well described while the remaining offices are not. Below is my attempt at descriptions based on the Bylaws, and what I think I understand. Please let me know if I missed or messed up anything.

### President

- 1- Officiate all regular Club meetings.
- 2- Appoint a Nominating Committee at the October meeting.
- 3- Appoint a Finance Committee after the November meeting.
- 4- Appoint an Audit Committee at the end of each fiscal year.
- 5- Appoint other Special Committees as needed. (Show Committee among others)
- 6- Appoint a Librarian.
- 7- Appoint a Web Master.
- 8- Serve as ex-officio member of all committees.
- 9- Serve on the Executive Board. The Executive Board is made up of all current Club Officers as well as the most recent past President. (Note; The Club Historian is appointed by the Executive Board.)

### **Vice President**

- 1- Assist the Club President in executing Club duties.
- 2- Fill in at meetings when the Club President is absent.
- 3- Serve on the Executive Board.

### Secretary

- 1- Take written minutes at all Club meetings.
- 2- Submit written minutes of each regular club meeting to the Web Master to be posted on the Club Web page.
- 3- Revise and resubmit written minutes after review at next regular Club meeting.
- 4- Serve on the Executive Board.

### **Treasurer**

- 1- Submit a financial report for review and approval at each regular Club meeting.
- 2- Handle all financial transactions associated with Club business. (Examples are- rent for meeting place, Club insurance, meeting ½ pot, meeting mini seminar cost, show expenses and prizes.....)
- 3- Ensure that the Sister Joseta fund is used only for financial aid to support the education of carvers.
- 4- File Club taxes.
- 5- Submit Financial report to Audit Committee.
- 6- Serve on Finance Committee.
- 7- Serve on the Executive Board.
